2. How long are your data stored? (In Addition to Hannover Re's Group DPCS)

We erase your personal application data twenty-four months automatically after the conclusion of an ongoing application process, i.e. after receipt of a rejection, discontinuation of the application process or contract offer. This does not apply if legal provisions prevent erasure or further storage is necessary for evidentiary purposes or if you have consented to longer storage.

If you do not delete your personal account in the Hannover Re application portal, your personal data will remain stored in your application profile for twenty-four months from the last change or activity, provided your application status is not active. This means that you can use it for further applications to Hannover Re. If you neither change your data nor apply for another position at Hannover Re within these twenty-four months and your application status is not active, your application profile will be automatically deleted after this period in addition to your personal account in the portal. In this case, only anonymised data will remain on the portal.

3. Would you like to complain about the handling of your data?

You have recourse to the local Data Protection Officer (contact details as above) or a data protection supervisory authority.

Privacy Notice

This Privacy Notice (“Notice”) sets out the types of your Personal Data which Hannover Re Malaysian Branch (“we”, “us” or “our”) may use, disclose, collect or otherwise process in accordance with the Personal Data Protection Act 2010 (“PDPA”), the purposes for the usage of such Personal Data, the classes of parties to whom we may disclose your Personal Data to, and the choices available to you on accessing and correcting your Personal Data.

This Notice shall apply to all persons who are job applicants, or who are already engaged in an employment with us, management trainees and/or interns (whether on a part-time or full-time basis and whether permanent or contractual basis).

Personal Data will include without limitation the followings:

- Name, date of birth, nationality, home address, correspondence address, contact details, photographs, and marital status.
- Age, gender, passport number, identification number, spousal details, dependents’ details, next-of-kin’s details and family members’ details.
- Educational background, employment application, employment history, work experience, areas of expertise, references, details of salary and benefits, bank details, performance appraisals, leave records, working time records and other management records.
- Any other information that may be necessary for lawful purposes as may be appropriate and required by law, directive, and/or regulations of any governing bodies.

For the avoidance of doubt, Personal Data in this Notice shall also include “Sensitive Personal Data” which shall consist of information including but not limited to physical health, mental health, thumbprint, DNA, political opinions, religious beliefs, or any other similar beliefs, commission or any alleged commission of any offence.

We collect Personal Data through several channels which include but not limited to the information that you may have provided to us by whatsoever means and/or in whatsoever manner; or given to us from other lawful sources.

We may use or disclose the Personal Data for the following purposes (“Purposes”):

- Human resources administration such as payroll, claims, tax and leave administration, recruitment, staff placement, training, performance review, salary/bonus reviews, succession planning, job’s suitability assessment, obtaining and maintaining health records which may include requiring you to complete or undertake a medical examination.
- General business management purposes such as administration of employee benefits, work facilitation, delegation of assignments and work-related travel arrangements.
- Claims administration, payment of benefits and handling of insurances.
- Survey, statistical and analytical studies relating to insurance/reinsurance businesses.

- Disciplinary actions, detection of any offence and investigations related thereto.
- Employment's verification or confirmation.
- Necessary investigations under any written law, criminal proceedings, civil proceedings or court order.
- Other lawful purposes as may be appropriate or required by law, directive, and/or regulations of any governing bodies.

- External human resources administration or travel administration.
- Independent agencies performing references and background checks.
- Claims investigation companies, loss surveyor or other necessary parties.
- Our consultants, fund managers, lawyers, accountants, or other professional advisers.
- Third party agencies providing survey, statistical and analytical studies/researches.
- Any organisations who contact us to verify your employment with us.
- Any lawful person or government authorities or law enforcement agencies.

We will take due care to ensure that reasonable and appropriate technical, security and confidentiality measures are taken to safeguard your Personal Data when we engage any third party or service provider.

We may also store the Personal Data in a database and our applicable systems located at the head office in Germany for the purposes of employees' management. The database and the applicable systems are controlled by our authorised administrative staff in Germany. We have security measures in place which will ensure the confidentiality of the information and the Personal Data contained in the database and the applicable systems.

We may access, review, monitor or produce any information, records and/or material including but not limited to email correspondences, internet log files, information in our network, server, cloud, computer or any other devices used by our employees. We will only do so in situations where it may be necessary, in the manner permissible by law, such as for investigations or protection of our legal rights or to respond to valid legal requests. We will exercise due care and will try to exclude, to the extent possible, irrelevant information.

If you have provided us with Personal Data of any third parties such as your spouse, children, next-of-kin and emergency contact, you warrant that you have obtained their explicit consent to allow us to collect, use and process their Personal Data.

By providing us with the Personal Data, you hereby consent to us disclosing the Personal Data to the parties and for the Purposes above-mentioned and you also hereby consent to us retaining the Personal Data for as long as necessary.

From time to time, we may ask our employees to review and update the Personal Data.

NOTIS PRIVASI

Notis Privasi ini ("Notis") menyatakan jenis Data Peribadi anda yang Hannover Re Cawangan Malaysia ("kami") boleh menggunakan, mendedahkan, mengumpul atau memproses menurut Akta Perlindungan Data Peribadi 2010 ("PDPA"), tujuan penggunaan Data Peribadi tersebut, kelas pihak-pihak yang kami boleh mendedahkan Data Peribadi anda kepada, dan pilihan yang tersedia untuk anda mengakses dan membetulkan Data Peribadi anda.

Semua pemohon pekerjaan, atau yang telah bekerja dengan kami, pelatih pengurusan dan / atau pelatih (sama ada kerja separuh masa atau sepenuh masa dan sama ada pekerja tetap atau kontrak) akan tertakluk kepada Notis ini.

Data Peribadi akan termasuk tetapi tidak terhad kepada yang berikut:

- Nama, tarikh lahir, kewarganegaraan, alamat rumah, alamat surat-menyurat, butiran hubungan, gambar dan status perkahwinan.

- Individu atau organisasi dalam kumpulan syarikat kami (syarikat induk, anak syarikat induk dan entiti sekutu).
- Pentadbiran sumber manusia atau pentadbiran perjalanan.
- Agensi yang melakukan rujukan dan pemeriksaan latar belakang.
